### **ADMISSIONS POLICY**

All students must be 18 years old and be able to provide a valid picture form of identification i.e. state drivers' license, state I.D. or passport. Verification of a valid Social Security Number / Card is a part of the enrollment process for certificated programs and will be kept in the students file. Fair Oaks Massage Institute does not accept ability to benefit students or ability to benefit exams as a criteria for admission.

### **ADMITTING STUDENTS FROM OTHER COUNTRIES**

#### **VISA Information:**

Students who attended high school or college in other countries are eligible to attend Fair Oaks Massage Institute. Visa services will not be provided. The Institution will not vouch for foreign students' status. Fair Oaks Massage Institute is not approved by the Bureau of Citizenship and Immigration Services (formerly, INS) to issue the I-20 for the F-1 Visa at this time.

### **INSTRUCTION IS IN ENGLISH ONLY**

Instruction and coursework, books, handouts, etc., will be provided in English only. If English is not the student's native language, an English proficiency exam will be required. The in-house exam is provided at the school at no charge. Students are required to read and write at the 12<sup>th</sup> grade level. English language services, including instruction as ESL, are not provided.

### **FINANCIAL ASSISTANCE**

Fair Oaks Massage Institute is NOT currently approved to offer financial assistance through Title IV federal funding. However, Fair Oaks Massage Institute does accept funding from Workforce Innovation and Opportunity Act (WIOA) programs; benefits from Veteran's Affairs; and, Vocational Rehabilitation grants.

To check for eligibility for one of the listed programs below, students will be counseled by a school official during the enrollment process. ### **LOAN ENROLLMENT AGREEMENT REQUIREMENTS**

If a student is eligible for a loan guaranteed by the federal or state government and the student defaults on the loan, both of the following may occur:

- 1) The federal or state government or a loan guarantee agency may take action against the student, including applying any income tax refund to which the person is entitled to reduce the balance owed on the loan.
- 2) The student may not be eligible for any other federal student financial aid at another institution or other government assistance until the loan is repaid.

If a student obtains a loan to pay for an educational program, the student will have to repay the full amount of the loan plus interest, less the amount of any refund, and that, if the student receives federal student financial aid funds, the student is entitled to a refund of the money not paid from federal financial aid funds.



## **STUDENT TUITION RECOVERY FUND (STRF) DISCLOSURE**

The State of California established the Student Tuition Recovery Fund (STRF) to relieve or mitigate economic loss suffered by a student in an educational program at a qualifying institution, who is or was a California resident while enrolled, or was enrolled in a residency program, if the student enrolled in the institution, prepaid tuition, and suffered an economic loss. Unless relieved of the obligation to do so, you must pay the state-imposed assessment for the STRF, or it must be paid on your behalf, if you are a student in an educational program, who is a California resident, or are enrolled in a residency program, and prepay all or part of your tuition.

You are not eligible for protection from the STRF and you are not required to pay the STRF assessment, if you are not a California resident, or are not enrolled in a residency program.

It is important that you keep copies of your enrollment agreement, financial aid documents, receipts, or any other information that documents the amount paid to the school. Questions regarding the STRF may be directed to the Bureau for Private Postsecondary Education, 1747 North Market Blvd., Suite 225, Sacramento, CA 95834; (916)574-8900 or (888)370-7589.

To be eligible for STRF, you must be a California resident or are enrolled in a residency program, prepaid tuition, paid or deemed to have paid the STRF assessment, and suffered an economic loss as a result of any of the following:

1. The institution, a location of the institution, or an educational program offered by the institution was closed or discontinued, and you did not choose to participate in a teach-out plan approved by the Bureau or did not complete a chosen teach-out plan approved by the Bureau.
2. You were enrolled at an institution or a location of the institution within the 120 day period before the closure of the institution or location of the institution, or were enrolled in an educational program within the 120 day period before the program was discontinued.
3. You were enrolled at an institution or a location of the institution more than 120 days before the closure of the institution or location of the institution, in an educational program offered by the institution as to which the Bureau determined there was a significant decline in the quality or value of the program more than 120 days before closure.
4. The institution has been ordered to pay a refund by the Bureau but has failed to do so.
5. The institution has failed to pay or reimburse loan proceeds under a federal student loan program as required by law, or has failed to pay or reimburse proceeds received by the institution in excess of tuition and other costs.
6. You have been awarded restitution, a refund, or other monetary award by an arbitrator or court, based on a violation of this chapter by an institution or representative of an institution, but have been unable to collect the award from the institution.
7. You sought legal counsel that resulted in the cancellation of one or more of your student loans and have an invoice for services rendered and evidence of the cancellation of the student loan or loans.

To qualify for STRF reimbursement, the application must be received within four (4) years from the date of the action or event that made the student eligible for recovery from STRF.

A student whose loan is revived by a loan holder or debt collector after a period of non-collection may, at any time, file a written application for recovery from STRF for the debt that would have otherwise been eligible for recovery. If it has been more than four (4) years since the action or event that made the student eligible, the student must have filed a written application for recovery within the original four (4) year period, unless the period has been extended by another act of law.

However, no claim can be paid to any student without a social security number or a taxpayer identification number.

### **SCHOOL SELF-MONITORING PROCEDURES**

Fair Oaks Massage Institute makes every effort to keep all policies and procedures up to date and to inform its students, instructors, and staff of current policies and procedures that are implemented by the Bureau for Private Post-Secondary Education (BPPE). The school catalog and enrollment agreement are reviewed annually and as needed, making changes necessary per the BPPE guidelines and implementing any new BPPE policies and procedures as required once notified.

Additionally, the school Director regularly reviews pertinent BPPE laws and regulations that affect the operations of the school. Copies of these documents are kept at the Administration Office as well as the updated school catalog and enrollment agreement. The school catalog, which lists the school policies, is also available on the school website.

If the BPPE makes changes to policies, procedures or requirements, the school Director will highlight and discuss BPPE updates on its policies and procedures during monthly staff meetings. Documentation of any changes in the school policies and procedures affected are reflected in the meeting minutes and the school catalog updated accordingly.

In instances where the BPPE policies and procedures have been implemented before the publication of a new catalog, the Administration Office will bring these to the attention of the students, instructors, and staff through the following:

1. Posting on the bulletin boards in classroom
2. Verbal announcement during classes
3. Once updated, the school catalog will be posted to the FOMI website

### **DESCRIPTION OF SCHOOL FACILITIES AND EQUIPMENT**

The Fair Oaks Massage Institute campus is located near beautiful Old Fair Oaks Village at 10723 Fair Oaks Blvd., Fair Oaks, CA 95628. The Fair Oaks Massage Institute campus includes the institute Director's office, Learning Resource Center and Student Services. The classroom will house approximately 18-20 students and has a restroom attached. Limited parking is available in front and side of the building. Additional free parking is available on the street near the office/classroom building.

Equipment and materials used in the classroom include ten massage tables (two students per table), folding chairs, stools, massage oil or lotion, essential oils, a skeleton for anatomy lectures, a flat screen TV and laptop for video demonstrations of massage techniques or anatomy examples and cleaning wipes for tables and chairs. Massage chairs are used in place of massage tables during the instruction on chair massage. Pillows will be used as props for side line and pregnancy massage. Students must provide their own sheets and hand towels.

### **STUDENT SERVICES**

Students of Fair Oaks Massage Institute are entitled to library resources, study groups, CAMTC counseling, career counseling, registration counseling, and financial assistance counseling. The Student Services staff is here to answer questions regarding registration/enrollment, provide copies of transcripts or certificates and to accept student tuition payments. Upon graduation, students will receive one copy of their transcript. Additional copies to be mailed are \$25 each. Student Services Staff can also make copies of incoming student documents and make appointments to speak with our Director.

## **DESCRIPTION OF LIBRARY AND OTHER RESOURCES AVAILABLE TO STUDENTS**

Fair Oaks Massage Institute has library and study resources available in DVD and online format.

Resources are available for use onsite in the office, not for checkout. The library resources study area is located within the administrative office, located at 10723 Fair Oaks Blvd., Fair Oaks, CA 95628. Resources include a few hundred DVDs on many bodywork modalities as well as access to [www.massagelibrary.com](http://www.massagelibrary.com) and may be accessed by a DVD player and laptop for use in the office. Students may access the resources by making an appointment during administrative office hours.

## **ATTENDANCE POLICY**

**Students are asked to contact the school immediately if they will be late or unable to attend class.**

### **Attendance Policy for Certification Programs:**

Attendance will be recorded for each class. Fifteen minutes late is considered tardy and consistent tardiness must be made up. It is the student's responsibility to make up missed time which may include setting up a meeting to go over what that student has missed with a staff member, as well as acquiring any handouts and homework that may have been assigned. Students who fail to maintain satisfactory attendance will be counseled. Attendance will be deemed unsatisfactory if more than 60 hours are missed. If attendance fails to improve, the Director may dismiss a student for unsatisfactory attendance. Re-admittance may be permitted if the cause for unsatisfactory attendance has been corrected.

Students must attend or satisfactorily complete all instructional hours. Applicants for CAMTC certification shall have attended 500 supervised hours total with 100 of those hours satisfying CAMTC specified subjects. When unable to attend, the hours that are missed must be made up and approved by Student Services for satisfactory completion. Students that are missing hours will not receive their certificate until all hours and class work is completed. Lost attendance hours must be made up as described below.

Students may make up lost attendance hours by:

- a) Per approval: Students attending the missed class(es) must pay a make-up fee at a rate of \$10.00/hour.
- b) All make up hours **MUST** be completed at Fair Oaks Massage Institute.
- c) All make up hours must be completed in person. This means that you may have to wait for your class to cycle through when the topic is offered again.

### **Attendance Policy for Non-certification programs/workshops:**

Students must attend or satisfactorily complete all instructional hours for non-certificated programs or workshops. When unable to attend, the hours that are missed must be made up and approved by Student Services for satisfactory completion. Students not meeting the attendance requirements will not receive a certificate of completion unless they are able to make up hours when the class is offered again at a make-up fee rate of \$10.00/hour.



## **PROGRESS REPORTS AND GRADING**

Our school's grading system is a pass/fail at 80% for each individual exam. Students must score 80% or greater on all examinations to pass the course, including written and practical examinations.

Practical examinations typically consist of one 1 hour massage as well as a continuous dialogue between the student and instructor/staff member regarding professional consultations with clients. Students that fail an exam must retake the exam.

## **HOUSING INFORMATION**

The Fair Oaks Massage Institute does not offer housing, facilitate housing plans nor help students find roommates. A rough estimate of apartment living in the area is between \$1,000-\$2,200 per month.

## **PLACEMENT ASSISTANCE/RATES**

No placement service or guarantee of employment is made to graduates of Fair Oaks Massage Institute; however, we do have known opportunities and vacancies in the field of massage that will be posted on the school bulletin board for our students and graduates to obtain information on local businesses that are currently hiring as well as special event postings that allow students to self-promote.

## **RETENTION OF STUDENT RECORDS**

Enrollees are advised and cautioned that California State law requires this educational institution to maintain school and student records for five (5) years. In addition, all transcripts are kept indefinitely in digital form. Upon written request, a student will have the ability to review their transcripts on file.

## **DRESS CODE AND HYGIENE**

As students represent the school and the therapeutic massage profession, it is imperative that certain standards be met and dress code and hygiene standards followed. During class periods, students may use their own judgment in attire, but it must conform to the codes of decency. During practicum, students are asked to abide by the following:

1. Student will be clean, free of body odor, and have well-trimmed fingernails.
2. All Students will wear comfortable pants that allow for movement and a short sleeved shirt or polo shirt.
3. Appropriate undergarments will be worn.
4. Shoes will be practical walking shoes that have non-slip soles and closed toes. Socks will be worn.
5. Clothes will be clean and free of odor.
6. Long hair will be pulled back. Beards and mustaches will be neatly trimmed.
7. Necklaces, rings and bracelets will not be worn and should be left at home.

## **CLASS AND CLINIC DRAPING AND SAFETY**

FOMI maintains strict standards of draping and modesty in all bodywork sessions taught in class and performed by students in the clinic. Students are taught to drape with care, intention, and regard for modesty and comfort and to always respect the rights of the person they are treating, be it a classmate or a client. No exposure of a person's private genital region will be permitted. Female breasts are covered at all times. Cell phones must be put away during hands on practicum sessions.

## **REQUIREMENTS FOR SATISFACTORY COMPLETION**

A Certificate of Completion will be issued to each student for our certification programs if all of the course requirements are completed:

- Attendance of all classroom and demonstration hours or satisfactory makeup of missed hours.
- Payment in full for the program.
- Completion of the Student Clinic Program, if applicable.
- Satisfactory scores (80% or greater) on all applicable written and/or practical examinations.

## **STUDENT ACHIEVEMENT STANDARDS – REQUIREMENTS FOR CERTIFICATION PROGRAMS TO RECEIVE CERTIFICATE/GRADUATE**

Certificate hours may include lecture, hands-on demonstrations of massage/bodywork techniques, student clinics, and homework. A student must complete all training and/or class hours in order to receive a completion certificate within 3 months of the last day of class:

- Attendance completed for all classroom and demonstration hours or satisfactory makeup of missed hours.
- Missed classes or course material may be made up by the student attending a later course when the classes they missed are recycling through the next class session, if seating is available, at a rate of \$10.00/hour.
- Full payment has been received for program:  
Tuition must be paid in full. All outstanding balances, including late fees, must be paid in full before the student is eligible to graduate.
- Successful completion of designated number of one-hour massages for the student clinic program: Assigned student clinic and practical hours must be completed.
- Satisfactory scores (80% or greater) on all applicable written and/or practical examinations: All examinations must be complete with a passing grade of 80% or greater.

Upon completion of the massage course, passing the exams, completion of student clinic hours and completion of any pertaining homework, the student will then be eligible to graduate and receive their certificate once their balance is paid in full.

## **REQUIREMENTS FOR NON-CERTIFICATION PROGRAMS TO RECEIVE CERTIFICATE**

Hours may include lecture, hands-on demonstrations of massage/bodywork techniques and homework. A student must complete all training and/or class hours in order to receive a completion certificate within 4 weeks of the last day of class:

- Attendance completed for all classroom and demonstration hours or satisfactory makeup of missed hours.
- Full payment has been received.
- Outstanding balances must be paid in full before the class begins.
- Missed classes or course material may be made up by the student attending a later course when the classes they missed are recycling through the next class session, if seating is available, at a rate of \$10.00/hour.

Upon completion of the course, passing any required tests, completion of any student clinic hours and completion of any pertaining homework, the student will then be permitted to receive their certificate once their balance is paid in full.

## **NOTICE CONCERNING TRANSFERABILITY OF CREDITS AND CREDENTIALS EARNED AT OUR INSTITUTION**

The transferability of credits you earn at Fair Oaks Massage Institute is at the complete discretion of the institution to which you may seek to transfer. Acceptance of the certificate you earn in the educational program is also at the complete discretion of the institution to which you may seek to transfer. If the certificate that you earn at this institution is not accepted at the institution to which you seek to transfer, you may be required to repeat some or all of your course work at that institution. For this reason you should make certain that your attendance at this institution will meet your educational goals. This may include contacting an institution to which you may seek to transfer after attending Fair Oaks Massage Institute to determine if your certificate will transfer.

### **TRANSFER OF CREDITS**

The Fair Oaks Massage Institute does not accept transfer credits from any other institution and does not have an articulation or transfer agreement with any other institution.

### **EXPERIENTIAL CREDIT**

Fair Oaks Massage Institute does not accept experiential credit at this time.

### **OTHER CREDITS**

Fair Oaks Massage Institute does not accept credits earned through challenge examinations and/or achievement tests.

### **DISTANCE EDUCATION**

Fair Oaks Massage Institute is approved through the Bureau of Private Post-Secondary Education (BPPE) and the California Massage Therapy Council (CAMTC) to provide two hybrid programs that combines online live interactive distance learning (IDL) and in person instruction for the 500 hour Clinical Massage Therapist program as well as the 620 hour Advanced Clinical Massage Therapist program. When the hybrid interactive distance education programs are offered for both the 500 hour Clinical Massage Therapist program and 620 hour Advanced Clinical Massage Therapist program, the online portion of the program is 190 hours and delivered **live** via Google Meet/Classroom. Any handouts needed for the live interactive distance learning classes are uploaded within 24 hours prior to the scheduled live online class. When the 190 IDL hours are met, the remaining hours for the 500 and 620 hour programs must be **in person, hands on training, with the instructor(s). The hybrid programs are treated just the same as the 100 % live, in person programs. All students must attend all online live and in person classes and have the same make-up policy, if classes are missed. The hybrid programs are subject to the same cancellation, withdrawal and leave of absence procedures as outlined in this catalog as the full, in person programs. All final tests and hands on evaluations are completed live, in person, with the instructor.**

### **UNFAIR BUSINESS PRACTICE**

California state law states that:

(a.) It is an unfair business practice for a person to do any of the following:

1. To hold himself or herself out or to use the title of “certified massage therapist,” or any other term, such as “licensed,” “certified,” or “CMP,” in any manner whatsoever that implies or suggest that the person is certified as a massage therapist or massage practitioner, unless that person currently holds an active and valid certificate issued by the council pursuant to this chapter.

2. To falsely state or advertise or put out any signor card or other device, or to falsely represent to the public through any print or electronic media, that he or she or any other individual is licensed, certified, or registered by a governmental agency as a massage therapist or massage practitioner.  
(b.)In addition to any other available remedies, engaging in any of the prohibited behaviors described in subdivision (a.) constitutes unfair competition under section 17200.

### **CERTIFICATION AND EXAM RATES**

Depending upon the student's professional path, students can opt to become state certified through the California Massage Therapy Council (CAMTC) or apply for a business license and somatic practitioner's permit in the local city/county in which they are planning to work. A business license may not be required if the therapist is not planning to be self-employed, but instead they will need a permit or to become state certified if they plan to be an employee. Additionally, if you are state certified and self employed, you will also be required to have a business license in addition to state certification through CAMTC.

### **BUSINESS LICENSE/PERMITS**

After certification at FOMI, students are eligible to apply for business licenses by contacting the city/county for which they are planning to work in if self-employed and/or are not state certified through the CAMTC. The requirements and cost for a business license or special permit to practice massage vary depending upon the city/county that the student is intending to work; so, inquiring to the specific area of where the student is looking to work is imperative.

### **STATE CERTIFICATION**

The California Massage Therapy Council (CAMTC) issues voluntary certifications to massage professionals that meet the requirements in the California State Law. Certification is voluntary. CAMTC Certification is not required by State Law in order for a massage professional to practice their profession in the State. However, some cities and counties locally require CAMTC Certification for massage professionals. To find out if your city or county requires CAMTC Certification, please contact the city or county in which you wish to practice. Local permits may be needed for each city or county where you practice unless you are CAMTC Certified. If you are in an unincorporated area, please check with the county.

Massage professionals may find CAMTC Certification useful as it allows certified individuals to practice their profession in all cities and counties in the State without the need to get a local permit to provide massage for compensation.

California Business and Professions Code section 4611 makes it an unfair business practice for anyone not certified by CAMTC to use the titles: Licensed, Certified, Certified Massage Therapist, Certified Massage Practitioner, CMT, or CMP.

In order to obtain CAMTC Certification, an applicant must submit a fully completed application to the CAMTC and meet all of the following requirements:

- Be 18 years of age or older;
- Pay the Certification Fee;
- Submit fingerprints to an authorized agency in California for a Live Scan using only the CAMTC form at [Request for Live Scan Service](#) (the authorized agencies charge you a fee for this service) and pass a criminal background check;
- Have all schools you attended for massage training submit original Official Transcripts directly to CAMTC in accordance with CAMTC's Policies and Procedures for Approval of Schools. Your school(s) must send your OFFICIAL SCHOOL TRANSCRIPT(s) directly to CAMTC electronically via email to [transcripts@camtc.org](mailto:transcripts@camtc.org). Transcripts must demonstrate that you have successfully completed, at

a CAMTC Approved School, curricula in massage and related subjects totaling a minimum of 500 hours (or the credit unit equivalent), which incorporates appropriate school assessment of student knowledge and skills. (See below for more information about closed schools and out-of-state education.) Of the 500 hours, a minimum of 100 hours shall be in anatomy and physiology, contraindications, health and hygiene, and business and ethics; and

- Have not violated any of the provisions of the California Massage Therapy Act or any policy, procedure, or regulation of CAMTC.
- Make a good, clean photocopy of the front of your Driver's License or Official State Identification to include with your Application.
- Get your Passport Photo taken to submit with application.
- The costs for state certification are based on rates as of today and are all subject to change. The cost is \$300.00 for the initial application, which lasts for two years. The renewal cost is \$300.00 and good for two years. The initial application will also require live scan fingerprinting at an additional \$75-100. To apply, you must have completed 500 hours of onsite training at an approved school. Currently, students will not be required to pass the MBLEx to receive certification through the CAMTC.

### **NOTICE TO CAMTC APPLICANTS**

**Passage of a CAMTC approved exam is not currently required for CAMTC Certification. While the law previously imposed this requirement, the requirement to pass a CAMTC approved exam has been suspended through December 31, 2026.**

“Attendance and/or graduation from a California Massage Therapy Council approved School does not guarantee certification by CAMTC. Applicants for certification shall meet all requirements as listed in California Business and Professions Code section 4600 et. Seq.”

### **MASSAGE/BODY WORK INSURANCE**

All students must have Bodywork (Malpractice) Insurance in order to start student clinic massages. Our students are eligible to apply for bodywork insurance through the American Massage Therapy Association (AMTA): 877-905-0577, [www.amtamassage.org](http://www.amtamassage.org), email: [info@amtamassage.org](mailto:info@amtamassage.org). Massage Therapist Insurance through American Massage Therapy Association (AMTA) ranges in cost from \$89 - \$235, annually. However, students are free to choose any bodywork insurance carrier.

## **STUDENT'S RIGHT TO CANCEL**

A student has the right to cancel their agreement for a course of instruction, without any penalty or obligations through attendance at the first class session or the seventh day after enrollment, whichever is later. After the end of the cancellation period, students also have the right to stop school at any time and to receive a pro rata refund if they have completed sixty (60) percent or less of the program and less a non-refundable registration fee, not to exceed \$200.00.

## **STUDENTS MUST CANCEL IN WRITING**

The written notice of cancellation to the school Director, if sent by mail, is effective when deposited in the mail properly addressed with proper postage. Students **do not** have the right to cancel by calling the school or by solely verbally communicating their request.

## **REFUND POLICY**

If the Enrollment Agreement is cancelled, the school will refund the student any money paid, less the non-refundable registration fee, not to exceed \$200, within 45 days after the notice of cancellation is received. Students who have withdrawn from the program without written notice, have 90 days to submit a written request for withdrawal and refund for the pro-rated amount of the program if they have completed 60 percent of the program or less. After 90 days of no written contact, the student is considered dropped and forfeits their refund. Since students are responsible for purchasing their own textbooks through outside vendors, new or used, they will need to seek textbook refunds through the individual vendor the books were purchased through.

## **WITHDRAWAL FROM THE PROGRAM**

Students may withdraw from the school at any time after the cancellation period of the Enrollment Agreement and receive a pro-rated refund if they have completed 60 percent or less of the period of attendance. No refund is available if they completed more than 60 percent of the program. The amount of that refund is to be "pro-rated" according to the incomplete portion of the program less the non-refundable registration, not to exceed \$200.00. The refund is to be paid within 45 days of withdrawal.

For the purpose of determining a refund under this section, a student shall be deemed to have withdrawn from a program of instruction when any of the following occurs:

- The student notifies the institution of the student's withdrawal or as of the date of the student's withdrawal, whichever is later.
- The institution terminates the student's enrollment for failure to maintain satisfactory progress; failure to abide by the rules and regulations of the institution; absence in excess of maximum set forth by the institution and/or failure to meet financial obligations to the school.



- The student has failed to attend class for 8 days.
- Failure to return from a leave of absence.
- For the purpose of determining the amount of the refund, the date of the student's withdrawal shall be deemed the last date of recorded attendance. For the purpose of determining when the refund must be paid, the student shall be deemed to have withdrawn at the end of 8 days.

### **LEAVE OF ABSENCE**

Students may request a leave of absence (LOA) from a certification program in the event of emergency or other compelling reasons. The request must be submitted in writing to the school Director. A leave of absence is granted one time, per student. The maximum amount of time for a leave of absence is one year. The student may then be admitted to a later course. Graduation will be delayed until attendance requirements are met. If a student does not return to complete the program after a leave of absence of one year, a refund will be calculated if they have completed 60 percent of the program or less, within 45 days of the one year LOA date. If more than 60 percent of the program was completed, no refund is available.

### **DROPPING OUT**

Students dropping out of the course may receive a tuition refund based upon the refund policy outlined in this catalog and the enrollment agreement. If dropping out, a request for refund must be in writing to the school Director. A refund is not available if the student completed more than 60 percent of the program. The last day of class attended will be considered the date of cancellation, whether or not a cancellation notice is given by the student to this institution. Students have 90 days to request a refund in writing or readmit into another program, however, the full tuition for re-admittance into the course would be required. If there is no contact from the student in writing after 90 days, no refund is available.

### **STUDENT COMPLAINTS**

Complaints may be directed to the school's Director either verbally or in writing. The complaint will be investigated thoroughly and if the complaint is not unfounded, the Director will work to resolve the issue(s). A summary of the complaint, its disposition and the reasons will be placed in the students file and entry of the complaint will be made in the log of Student Complaints as required by California State Education Code Section 73870.

A student may lodge a complaint by communicating verbally/or writing to any teacher or office personnel. The recipient of the complaint shall transmit it as soon as possible to the Director. If an oral complaint is not resolved within a reasonable period or before another complaint is made, the student will be advised to submit a complaint in writing. If a student complaint is in writing, the institution shall, within 10 days of receiving the complaint, provide the student with a written response, including a summary of the institution's investigation and disposition. If the complaint or relief requested by the student is rejected, the reasons for the rejection will be stated. The student's participation in the complaint procedure and the disposition shall not limit or waive any of the student's rights or remedies. Any document signed by the student that purports to limit or waive the student's rights and remedies is void.

## **STUDENT GRIEVANCES**

The Student Grievance procedure is available to any student who believes an action or decision of the administration or Fair Oaks Massage Institute staff has adversely affected their status, and/or rights.

If a student wishes to log a grievance, it is necessary for the student to submit a written statement and submit it to the school Director at Fair Oaks Massage Institute in person, through the mail or fax, following the same procedures as outlined in the request to cancel or withdraw.

The student grievance letter will include a description of the issue, as well as the date of the grievance and the student's signature. This letter is then copied for their records to their student file, the grievance file and is submitted for review to the Director of the school. The school Director will have up to two weeks to investigate, interview associated parties to the grievance and outline a course of action in writing, to resolve the grievance.

If the student who issued the grievance does not agree with the resolution of the grievance issued by the school Director, the student may appeal the grievance in writing. Again, writing the date and reason for the appeal of the grievance to the Director and submitting it in person, through the mail or fax. The director will have two weeks to consider the appeal and course of action and respond in writing. The outcome of the appeal may result in a neutral third party mediator.

## **PROBATION**

Students that receive complaints may be immediately placed on probation depending upon the nature of the situation. The probation period will last for a total of two weeks. If within this time frame additional complaints are received, the student may be dismissed from the program. At the end of two weeks, if the student has been in compliance with school policies, they will be removed from probation. The following reasons may be cause for probation but are not limited to these situations:

- Being intoxicated or in a drugged state on school grounds.
- Behavior that creates a safety hazard to other people at the school.
- Failure to comply with instructor's requirements, or disrespectful behavior to other students, an administrator, faculty member or student clinic client. Rumors and gossip will not be tolerated.
- Making any verbal or physical threats against other students or staff/faculty.
- Receiving a complaint from any student, staff/faculty

## **CONDITIONS FOR DISMISSAL**

2. A minimum of 15 hours of Business including, but not limited to, professional development, obtaining and maintaining credentials, and adhering to laws and regulations. These hours may be in-person or synchronous interactive distance learning in accordance with current CAMTC Procedures.
3. A minimum of 25 hours of Hands-On Massage including, but not limited to, client assessment and interview, client draping, massage application, and planning and administering an individualized therapeutic massage. These 25 hands-on hours must be in-person and may not include student clinic hours. ii. All hours must be under the active and direct supervision of qualified instructors. For the hours to be considered successfully completed, students must be comprehensively assessed and evaluated by qualified instructors. All assessments, both physical and written, must be completed in person. The school shall document its determination that the student possesses the skills necessary to safely perform massage therapy on members of the public in accordance with California law and CAMTC's Policies and Procedures, and directly transmit the results of the assessment to CAMTC.
4. Schools with CAMTC Approved Out-of-Country Supplement Programs must report the results of all students in the program to CAMTC. This is a pass or fail workshop based on test results and hands on evaluation of the instructor.

If a student fails the out-of-country supplement program, then CAMTC will not accept the out-of-country completed education and the student must complete an additional 450 hours of education at a CAMTC approved massage program.

If a student passes the out-of-country supplement program and provides satisfactory evidence that their prior out-of-country education is substantially equivalent to that of a CAMTC Approved Program, then the student meets the education requirements for CAMTC Certification.
